-Buckshot ONLY.

-An orange hat and vest is mandatory.

-A radio is mandatory.

-Guns are to be loaded on stand ONLY.

-Bolts should be kept open unless on stand.

-Carry your firearm in a safe manner.

-Captain/lead man is the only one with a loaded gun going to stand.

-Guns should be cased in vehicles at all times, a sock case is recommended.

-Doe, fox, and coyotes NOT to be shot unless otherwise instructed by a captain.

-Do not leave your stand for any reason until the drive is OVER.

-Do NOT chase after a wounded buck.

-Bucks will be checked in ASAP and signed in on the deer post by the shooter.

-It is your responsibility to tag and properly affix required information to your deer.

-Drivers will be instructed by captain to lead off the left or right.

-Drivers shall announce "standers ahead" this means NO SHOOTING AHEAD OF YOU by ANYONE.

-Violations will be addressed by committee and captains.

-Each stander should know his safety zone. If you don't know ASK.

-If you shoot a buck - you buy a bottle!
